Energy Plan Period

This Energy Plan is for 12 months from the Supply Start Date unless it ends earlier

Benefits

Consumption: During this Energy Plan, the total usage Charges will be 15% lower than the applicable Discover Energy base offer usage charges.

Solar Feed-In: During this Energy Plan, Solar Feed-in will be paid at the following rates:

- First 3.2877kwh per day: 30c/kwh
 - Next 3.2877kwh per day: 18c/kwh
 - All remaining kwh: 9c/kwh
- (all usage thresholds will be calculated daily, see our [FAQ](#)'s for more details)

VPP Peak Events: During this Energy Plan, Energy Discharged from your operated product by Discover Energy during a VPP Peak Event will be paid at the following rates:

- 25c/kwh plus 50% of any profits made from the traded energy

VPP Off-Peak Events: During this Energy Plan, Energy Charged to your operated product by Discover Energy during a VPP Off-Peak Event will be paid at the following rates:

- Charges will not apply to consumption kwh charged to your operated product by Discover Energy during a VPP Off-Peak event.

***VPP Self Trade:** During this Energy Plan, energy Discharged from your operated product by an operator¹ other than Discover Energy will be paid at the following rates:

- 25c/kwh plus 80% of any profits made from the traded energy

Prices

We may vary the Supply and Usage Charges, the Solar Feed-in Rates and charges (in accordance with our Terms and Conditions with written notice to you)

Payment Method

Automatic Direct Debit or Credit Card only

Billing E-billing

Metering Smart Meter only

How can this Energy Plan end?

If our Agreement to supply you with energy ends, this Energy Plan will also end - including if you move to another address.

You can end this Energy Plan at any time.

We can end this Energy Plan:

- This is a Fixed Term Contract. We will notify you prior to the end of your term that the Market Contract will terminate and the supply of electricity will continue under a Standard Retail Contract;
- if your operated product does not remain eligible for this offer¹
- if you stop being a Small Customer; and
- if we withdraw this Energy Plan from sale – refer to the Agreement Terms for details.
- If your premises register a requirement for life support equipment.

¹In the event that your operated product is ineligible we will notify you in writing, your offer will revert to the offer you were on immediately prior to entering this offer. If you are a new Discover Energy customer, you will be placed on the relevant Smart Saver Offer.

**Note: Self Trades may incur losses if trades occur during times where rates are lower than feed-in prices – Trades at a loss are paid as follows:*

- 25c/kwh plus 100% of all losses made from the traded energy
